Apex PEAK-TIQUE Antiques and Collectibles Festival is organized and managed jointly by the **Apex Downtown Business Association** (ADBA), the **Apex Historical Society** (AHS) and the **Town of Apex** (TOA). For the purpose of this agreement they shall be referred to as the Host. The applicant and exhibitor shall be referred to as the Dealer. This agreement is between the Host and the Dealer.

**This festival is for ANTIQUES and OLDE' COLLECTIBLES ONLY.** NO new or house hold items, counterfeit items, or crafts may be displayed or sold. Additionally, Firearms newer than 1898, ammunition, explosives, drug related items, pornographic materials, food, beverage or animals are not allowed to be sold. Repurposed and/or repaired antiques are acceptable. The Host reserves the right to audit all booths and to have you remove any items at any time from your booth that do not meet the image of the Festival. Collectibles must be made before 1975.

## PEAK-TIQUE *Contract Terms* Antiques and Collectibles Festival

1. Show Hours: Friday, September 11, 2020, 9am to 5pm. Saturday, September 12, 2020, 9am to 5pm., and Sunday, September 13, 2020, 10am to 4pm Set up is from 8am to 8pm on Wednesday, September 9, and Thursday, September 10. Dealers must have their area ready for showing by 9am Friday. Items for sale must have visible prices. Dealers may dismantle their booth between 4pm and 10pm after show closes Sunday at 4pm. Booths are outside only.

2. The Host will assign spaces on a first come basis to each Dealer. The Host will do its best to accommodate all Dealers with an appropriate choice of space(s) based upon the type of merchandise exhibited and their requirements. Dealers will be notified of acceptance of the contract within fifteen (15) business days of receiving reservation and payment. If, for any reason, the Host does not approve the contract, the payment will be refunded to the Dealer in full within fifteen (15) business days.

3. Dealers agree to truthfully represent their merchandise and have prices clearly marked. Apex PEAK-TIQUE staff and management reserve the right to photograph any person, or merchandise, during the Festival.

4. Dealers are responsible for the tent and tables in their booth.

5. Dealer pets must be properly restrained during show hours within their booths. Pets are not allowed to roam freely. Dealers agree to dispose of all pet waste properly; violations will result in loss of pet privileges.

6. Communication is expected from dealers. If you change your address, phone number, email address, etc., it is your responsibility to inform the PEAK-TIQUE Host of the changes so that we may update our database.

7. If Dealers do not show up on set up day, their booth may be resold and may be moved to another location at management's discretion, as long as booths are still available and it does not disrupt the show. If for any reason you are unable to arrive during set up time, you must notify the Host to save your Booth.

8. Dealers should be in their booth at all times or have someone covering it. Dealer is responsible for his own merchandise.

9. Foul language and general rudeness will not be tolerated. Host staff are happy to help Dealers handle situations if necessary.

10. The Host is not responsible for the merchandise or any property of the Dealer. Property that may be damaged, stolen or lost before, during and after the show is not the responsibility of the Host, its affiliates, agents or the operators of the venue.

11. Dealer agrees to comply with all rules and regulations of the show. The Host reserves the right to terminate the Dealer's agreement at any time if there is a breach of this agreement, or any show rules, by the Dealer. If this occurs, no deposits or agreement fees will be refunded.

12. The Host is not liable for Acts of God which may result in the cancellation, rescheduling or modification of the event. It is understood by all parties there will be no rain or inclement weather delays.

13. All Dealers shall comply with all applicable laws and regulations concerning NC and NC sales tax.

14. We encourage special signs to highlight your product or service. To maintain the caliber of our show, discount signs are not allowed. The Host reserves the right to have Dealers remove signs not in keeping with the show's image.
